UPDATE FROM PASTOR BRAD

As I reflect on this past year, 2023, I am grateful for all of you. I feel as if this year was a year of community building, growing in our relationships with God and growing in our relationships with each other. It was another year of many visitors in worship and welcoming many new faces in worship, at ministry events and new members to the congregation.

One thing we learned as a congregation this past year is that we truly are on both sides of the spectrum when it comes to politics and social issues. What we have come to understand is that our focus is on our faith in God and we come together in unity of our faith in Jesus

Christ, our Savior and Lord. We aren't always going to agree with one another, but we can still be church together.

As you go through this annual report, you will see all of the ways we have been working towards our mission. There were so many wonderful events that happened this past year across our ministries of Gather, Serve and Celebrate. Our property team was very active working on a number of different projects. Our Early Learning Center continues to do well and make an impact in our community. Financially, we continue to run a deficit budget, but we ended the year better off than we expected and hope to close that gap next year.

I am grateful for our St. Philip staff and all they do as leaders as they serve in their roles for the sake of God's work here at St. Philip, for the sake of the members of our congregation, those around us, and those in need locally and around the world.



CELEBRATE

Worship

Throughout this year we have continued to worship at 9am every Sunday with an average attendance of 150 people in person and 20 logins on Zoom. St. Philip continues to be known for being a warm and welcoming community for visitors.

At the beginning of 2023, we did a three-month trial on how to do Saturday Evening Worship. We worshipped in the sanctuary, in the fellowship hall as dinner church and then in the new chapel. It was decided to have worship on Saturday Evenings twice a month on the 2nd and 4th Saturdays of each month starting at 5pm. This service is held in the Sanctuary using the Holden Evening Prayer liturgy. The average attendance for this service has been 20 people since April.

Rally Day and Hog Roast

The Men's Group hosted a Hog Roast as a fundraiser on Rally Day to raise funds for the Sanctuary Upgrades project. There were 20 men who helped make the event possible. We began with worship outside in the courtyard and then moved to lunch. There were about 177 in worship and about 150 attended the Hog Roast where there were caricatures, games and a dunk tank where Pastor Brad got dunked over and over again. The event raised about \$12,000.





PROPERTY

Chapel - The Chapel project was completed at the beginning of 2023 and is a lovely and cozy space. It is being used weekly by the youth on Wednesday evenings for closing worship and by other groups for Bible study or meetings.



Re-siding the Hedeen Center/ Early Learning Center - The property team replaced the siding to help improve the look and integrity of the building.



Hail Damage to the Roof - In June, we had a severe hail storm come through and damage our roof. The insurance company determined that the roof needed to be replaced. The work will be done in the summer of 2024.

- Security Upgrades In an attempt to continue to keep the children of our Early Learning Center safe while they are here at school, we have installed an automated door system on four of the church doors. These doors can be opened with a key fob and two of them have call systems.
- Rezoning for a Cell Tower We continue to be in communication with AT&T about building a telecommunication tower on our property. The first step is to change our zoning from R1 (Residential) to PD (Planned Development), which we are still in the process of completing.
- Fundraising for the Sanctuary Upgrades project - Over the last year, we have raised \$55,000 to build a new A/V booth, add robotic cameras and update the lighting system in the sanctuary. These projects will be completed in 2024.

Ken Caryl Concert 2023 Report

Ken Caryl Concerts produced four concerts in 2023 – "Celebrating Women in Music" on March 12, "Saturday on the Seine" on May 20, "A Night at the Opera" on September 30, and "Songs of the Season" on December 10. Performers included church and community members, both professional and amateur. Audiences included in-person attendees as well as virtual attendees on Zoom and viewings on YouTube in the weeks following. The December concert was our most well attended performance, with 200 people in the sanctuary that evening. In addition to entertaining our audience and providing space for our musicians to be creative with their talents, we raised awareness for global and international causes this year:

- The Iranian Women's Movement
- Ukrainian Refugees (donated \$150 from our free-will offering to St. Philip member, John Breed to aid his summer trip working with refugees in Poland)
- The Association for Frontaltemporal Degeneration (donated \$200 from our freewill offering)

The total cost of presenting the 4 concerts was \$3,457.67 and total freewill offering collected was

\$1,173.25. The church council approved a grant of \$1,500 from the Thrivent Choice designated fund.



Serve Ministries

Building relationships through Christ to serve in our community was definitely evident

this past year. Our "Dipes and Wipes" ministry, which is a partnership with Love INC (Love in the Name of Christ) has been a huge success. Every month we distribute diapers at St. Philip to an average of 25 families who are pre-qualified with Love INC. Not only are diapers being provided, but trusting relationships have been formed with clients; especially as our prayer partners meet with them to talk, listen, and pray. Their children also attend and are supervised with adults and youth volunteers who play with them so the parents can have adult conversation and prayer time. Thanks to our dedicated team of Dipes and Wipes volunteers!



"Holy Hammers" is another ministry that is back in action at St. Philip. Holy Hammers is a coalition of churches that works cooperatively to support Habitat for Humanity to build affordable housing in the Denver Metro Area. Thanks to Rich and Juley Allee for their leadership in communication, recruiting, and working at Habitat builds. This past year we had volunteers who served at the Habitat Restore, others who worked at the Miller Street Homes in Wheat Ridge, and others attended the



Breakfast for Humanity which raises awareness and funds for Habitat. St. Philip raised \$1,142 by participating in the "Gingerbread Build" fundraiser that our youth created. Your generosity and partnership helps provide affordable housing to those in need.

Last Christmas your donations to "Lutheran Family Services" gave Christmas gifts to over 50 families! Thank you for providing joy to so many children and parents at a crucial time.

Our "Community Garden" raised vegetables that contributed to the Sharing with Sheridan Food Pantry, and we had seven participants active in the Annual "Crop Hunger Walk" which raised \$150 for local organizations providing food for those in need, including our Sharing with Sheridan Food Pantry.

Your contributions to the College Outreach ministry continue to bless 49 students all across the country. Students often comment how much they appreciate your gifts during the stressful times of finals and midterms.

Sharing with Sheridan Food Pantry (SwS) continues to offer weekly food distribution to people experiencing food insecurity. SwS operates every Thursday in the parking lot of the Sheridan Recreation Center using a drive through/walk through model. Each week, more than 30 volunteers (many from the community beyond St. Philip), organize, package, register, distribute, and clean up. In addition, other volunteers are involved behind the scenes. In 2023 Deacon Korra started providing monthly prayer opportunities to neighbors waiting in line. 2023 was a record-breaking year. We experienced dramatic growth, serving 27,000 neighbors over the course of the year, a 50% increase over the prior year. Through the efforts of our volunteers and the generosity of the extended St. Philip community, other organizations, and grants, we continue to provide a choice of food and other items to our neighbors. Our partnerships with Food Bank of the Rockies and the Food Exchange Resource Network (FERN) are invaluable. SwS has also been involved in the Sheridan community, attending some events and providing food for other local activities. We have an excellent partnership with the school corporation and the local government and have participated in a variety of discussions, webinars and information gathering sessions. People signed up to decorate a table for a specific month and someone made a dessert specific for each month. It was a great event full of fun, decorations and a large variety of wonderful desserts! The Puppet Praise Ministry even did a puppet show with celebration songs and leading us in Happy Birthday.



VACATION BIBLE SCHOOL

VBS was a great success again this year as we had 93 kids attend with 50 volunteers. On Thursday evening, there was a barbeque outside with the evening program. This was a great outreach to our community and Early Learning Center families.



YOUTH AND YOUNG ADULT SUMMER MINISTRY

This summer we had a wonderful summer youth group and summer trip. The summer trip included youth and young adults. The theme of the trip was God's Creation as they spent the week in the Mountains at the YMCA of the Rockies in Estes Park. The group enjoyed hiking, serving, Bible study, a sunrise hike and fellowship all around the theme of "God's Creation." It was a blessing to have Taylor White, one of our college students, as the youth summer intern.



PUB THEOLOGY

Pastor Brad led Pub Theology at Locavore Beer Works each Monday throughout this last year. This is a great ministry reaching a variety of different people and has been a great outreach as well.

MEN OF ST. PHILIP

The Men of St. Philip group was reborn in 2023 with new leadership, creating a new vision and rebuilding. The men are now meeting twice a month for pizza night in addition to its Bible Studies and Men's Breakfast at iHop every Thursday morning. The men all got together to plan and coordinate the Hog Roast on Rally Day.

WOMEN'S MINISTRY

The women's ministry is blessed to have a number of women's groups and Bible studies to fit the needs and schedules of many. As a result, there have been many more women involved and part of a Bible study or small group, which is such as blessing to them, the community and their faith.

St. Philip Mission Endowment Fund 2023

Grant awards were communicated to the congregation via the SPIN and grant application times were in Sunday announcements and the SPIN.




